## Virginia General Assembly Session Calendar

The following is the schedule for the upcoming 2005 Virginia General Assembly session. This year's session ends almost 2 weeks earlier than last year. You can access the entire calendar at <http://leg1.state.va.us>.

Your legislator should be contacted as soon as possible if your locality plans on requesting legislation for the next session. Contact information for each legislator can be found at either <http://leg1.state.va.us/Senate/Senators/htm> or <http://leg1.state.va.us/house/delegates.htm>.

### Date            Actions

12/13/04 ..... All draft requests for legislation to be pre-filed to Legislative Services.

12/17/04 ..... Budget submitted by Governor.

1/7/05 ..... Deadline for requests for drafts of study resolutions.

1/11/05 ..... All final drafts of legislation to be pre-filed available at Legislative Services by noon. All requests for drafts, redrafts and corrections for first-day introduction bills to Legislative Services by 5 p.m.

1/12/05 ..... Pre-filing ends at 10 a.m. Legislative session convenes at noon.

1/14/05 ..... Last day to request drafts and redrafts. All requests and corrections must be received by Legislative Services by 5 p.m.

1/21/05 ..... Last day to file all bills and joint resolutions.

2/3/05 ..... Last day each house considered own legislation excluding action on appropriation, debt, revenue, VRS and Budget.

2/6/05 ..... Midnight deadline for Budget Bill committees to complete work.

2/8/05 ..... Amendments on Budget available by noon.

2/9/05 ..... Cross Over day; each house considers legislation from the other house.

2/16/05 ..... Last day each house to act on revenue bill of the other house.

2/18/05 ..... Last day to file joint commending and memorial resolutions.

2/21/05 ..... Last day for any committee action on legislation by midnight.

2/24/05 ..... Budget Bill conference report available. Last day to put bills in conference.

2/26/05 ..... Adjournment.

4/6/05 ..... Reconvened session.
